

"Dreaming of the Future" Scholarship Official Rules

NO PURCHASE NECESSARY. A PURCHASE OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: The Baby Sleep Site's "Dreaming of the Future" Scholarship is open to high school and college students from an under-represented group including but not limited to single-parent households (whether you're the parent or the student), parents returning to school after having a child/children, minority students, parents of children with disabilities, students with disabilities, etc. High School students must be 15 years old at least and provide an Enrollment Certificate. College students interested in participating in the scholarship program must be enrolled at an accredited university or college and 18 years or older. Open to high school and college students of the United States for the current school year. In addition, each applicant must have an acceptance letter from an accredited university, college, or high school. Employees of The Baby Sleep Site as well as the immediate family (spouse, parent, sibling and children) and household members are not eligible. The scholarship program is subject to all applicable federal, state, and local laws and regulations and is void where prohibited.

2. Agreement to Official Rules: To participate in this scholarship program, participants need to agree to these Official Rules and Sponsor's and Administrator's decisions unconditionally, which are final and binding in all matters related to this scholarship program. computer is the official time-keeping device for the Contest. The \$1,500 Scholarship Prize will be awarded to one winner in the Spring and one winner in the Fall.

5.How to Enter: During the Entry Period, visit <https://www.babysleepsite.com/scholarship> and follow the instructions to complete and submit the registration form, including your valid personal information for verification.

Limit:

- In the event of a dispute regarding any Submission, the authorized account holder of the email address used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Each potential winner may be required to show proof of being an authorized account holder.

6.Winner Determination: After the conclusion of each Entry Period, a panel of qualified judges determined by Sponsor in its sole discretion will select a potential winner from all eligible Submissions received, based on a predesignated rubric scoring system.

7. Winner Requirements: Potential winners will be notified by email or phone within 30 days of the deadline set forth above. Except where prohibited, each potential winner (parent/legal guardian if a winner is a minor in his/her place of residence) will be required to sign and return a Declaration of Compliance, Liability and Publicity Release, which must be received by Sponsor within seven (7) days of the date notice or attempted notice is sent, in order to claim his/her prize. If a potential winner cannot be contacted, fails to sign and return the Declaration of Compliance, Liability and Publicity Release or provide any other requested information within the required time period, or does not comply with these Official Rules, potential winner forfeits the prize. If a potential winner is disqualified for any reason, the prize may be awarded to a runner-up determined by the qualified judges, in Sponsor's sole discretion. Only three (3) alternate winners may be determined, after which the applicable prize will remain un-awarded. Each winner accepts and acknowledges that Sponsor shall not be obligated to use the Submission and that Sponsor in its sole discretion shall have the right to refrain from using the Submission. Sponsor shall not incur any liability whatsoever to the extent Sponsor chooses to refrain from any exploitation of its rights hereunder. Each winner will indemnify Sponsor, Released Parties (as defined in Section 9, below) and any licensee of Sponsor against all claims, damages, liabilities, and expenses (including reasonable counsel fees and legal expenses) arising out of any breach of these terms.

8. Awards of Scholarships: Two (2) winners will be selected among the participants in 2021. Each Scholarship Award will be in the form of check to the accredited post-secondary institution of higher education attended by the Scholarship Award Recipient (if the Scholarship Award Recipient has enrolled in an accredited post-secondary institution of higher education and submitted proof of enrollment to Sponsor). The checks will be mailed to the winner within fourteen (14) business days of winner verification. Scholarship Award Recipients must submit proof of enrollment for the current quarter/semester. Scholarship Awards may not be assigned, transferred, or changed, except at the sole discretion of couponbirds.com. No substitution or transfer of prizes is permitted. Any taxes due on the Scholarship prize or any other prizes

All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the State of Ohio without giving effect to any choice of law or conflict of law rules (whether of the State of Ohio or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Ohio.
